### Who can become a member?

#### Two types of membership:

**Full Members:** These are Iwi, Maori and Pacific Island and Community or voluntary housing organizations and groups which are either: providers of Community housing, or groups intending or seeking to become providers of Community- housing, or groups of residents/tenants of community housing, or groups which advocate for Community housing or residents of Community housing as part of their work. Full member organizations have one vote each at the AGM and receive access to all CHA member services

**Partner Members:** These are individuals, local authorities, private development companies, and other private and public entities which invest, operate, own or develop affordable, Community and/or Social housing. Partner members receive access to all CHA member services, but are not able to vote at the AGM.

**Full or Partner Members pay the same rate: \$250 + GST= \$287.50 per year (1 July – 30 June)**
