Proposed Housing Policy Aim

People of Christchurch have access to secure, adequate, healthy affordable homes

Community Outcomes on housing:

- Affordable
- Range
- Quality
- Sufficient

Context

- Social outcomes, community make-up
- All in it together: Public, Private, NFP
- Pre-quake and post-quake drivers
- Affordability, access, tenure
- Demographic issues

Proposed Principles: The ‘Why’

1. Adequate, accessible and affordable housing is a human right.
2. Security of tenure is a foundation to building strong communities.
3. Collaborative action to address long term social and economic challenges to housing facing Christchurch.
4. Quality, well-designed housing for supporting the social, economic and environmental recovery of Chch.



Principles: The 'Why' (contd)

5. An active role from all sectors of society to ensure the long term availability and affordability of housing of all tenures.
6. Housing options and pathways for households to overcoming affordable housing barriers.
7. Housing outcomes are linked to social, economic, environmental and health.



Proposed Goals: The 'What'

1. Increase supply, availability and social sustainability of quality, affordable housing to meet community need.
2. A demand driven approach to defining, addressing, and developing targets for, social and affordable housing.
3. Work with other agencies to provide accessible services and support to address homelessness.
4. Develop ways to ensure the co-ordinated long term promotion, provision and retention of affordable housing.
5. Promote, support and provide mixed housing that include a range of housing types and tenures.

Goals: The 'What' (contd)

6. Proactively influence affordable housing issues and address barriers to its provision by making the best use of legislative, planning and regulatory opportunities.
7. Develop capacity and capability to support housing actions to address housing challenges.
8. Improve, develop and share information and intelligence on housing issues for collaborative action.
9. Supporting quality housing developments that create inclusive communities and overcome exclusionary housing practices.
