Context for review

Review of emergency housing funding is part of a broader social housing reform programme that aims to create:

 a fair, efficient and effective social housing market which will better support people in greatest need for the duration of that need

New role for MSD from April 2014:

- · needs assessment for people seeking social housing
- · purchaser of social housing places.

MSD now taking a lead on emergency housing work.

Emergency Housing Funding Review

Funding review commissioned in December 2014 by the Minister for Social Housing as part of a range of initiatives to alleviate pressure on emergency housing that included:

- One-off \$500,000 cash injection for emergency housing providers
- · Review of funding for emergency housing:
 - Due to be completed by July 2015

Emergency Housing Funding Review

Why do we need a review?

- · Increasing pressure on emergency housing providers
- Lack of clarity about the funding that goes into the sector (from government and other sources)
- No clear definition of emergency housing

Emergency Housing Funding Review

The review will aim to:

- provide clarity about the current funding landscape (i.e. what funding providers receive from which sources and what this funding is used for)
- establish clear objectives and outcomes from government funding in this area
- make recommendations about future funding arrangements in this area to put the sector on a stable footing.

Emergency Housing Funding Review

We are proposing a two-phase approach to this review:

- Phase 1 an information gathering stage to understand the full picture of emergency housing funding and the issues this raises – by end May
- Phase 2 the development of options and recommendations for change to the funding model for emergency housing – by end July.

HOUSING ASSESSMENT

Provider survey

We are using a broad working definition of emergency housing:

- from urgent and very short-term accommodation for people (e.g. night shelters)
- to longer-term accommodation (for weeks or possibly months) that supports people while they transition.

We want to understand more about:

- Emergency housing (how much, length of stay, cost etc)
- Related services providers may offer for people using emergency housing (e.g. wrap around support services)



HOUSING ASSESSMENT

We want to understand:

- Do you define emergency housing or have criteria for your service?
- Who is providing emergency housing?
- How do you determine who accesses your emergency housing?
- How do people get referred to you?
- How do you work out your costs (e.g. for bed and board, other services etc)?
- How do you meet these costs?
